Notes on the application form for product testing/certification

Related to 2.1 / 2.2:

We would like to point out that both the product description/designation and the type specified here are components of the test certificate and are therefore listed there in the specified wording. If changes are made to the product description/designation or the type designation during the testing or certification process, these must be notified to the testing and certification body as soon as possible. Costs incurred due to incorrect identification on the certificate and subsequent changes to the certificate documents shall be borne by the customer.

Related to 2.5:

For products with internal combustion engines that do not comply with the regulations in force in the EU (Regulation (EU) 2016/1628), only test certificates can be issued. Certification is excluded.

Related to 4:

Until the new EU Regulation 2023/1230 (MVO) comes into force on 20 January 2027, services can be commissioned in accordance with both Directive 2006/42/EC and EU Regulation 2023/1230.
